I, Troy Lehman / Defendant wish to add  
to the Appellant Brief - which I DID NOT  
receive until Sept 13, 2011. I would  
beg The Supreme Court to please  
accept this statement of facts. Mr  
Ryan Youngren IS AN OBIT AND OBIT  
LIAR ~ AND ~ This Kidnapping charge  
was based on a lie told by Patty  
La Croix to Fargo P.D and pursued  
by Mr. Youngren that "Troy Lehman  
requested money or methamphetamine

to let Daniel Flying Hawk go." But when Patty Le Croix was asked by Mr Youngren at my trial if I did in fact ask for this - She said "No, he did not" - I offered it to him." Mr. Youngren is now fully aware that my charges stem from a lie, yet he proceeds with the case, violating my 6th amendment rights. Mr Youngren goes on to lie to the Supreme Court several times I see in his appellate brief. He leads the Supreme Court to believe that I just went to Flying Hawk's aunts house and grabbed him and "then" called Mr. Schenkein of Affordable Bonding, & asked "He Is A Lie" - Fact is the Mr. Schenkein and myself were in telephone contact days before Nov 7, 08 - as testified to in court by Mr. Schenkein and Mr. Stubstad of Stubstad Bonding whom Schenkein called days before Nov 7-08 as a reference to my abilities. Everyone seems to avoid the fact that Mr. Schenkein told me to hold Flying Hawk until Ms. Mitchell got to Fargo - And

it was about (2) hrs as she lives North of Detroit Lakes. There is No law city state or federal stating how long a bounty hunter can detain a bond skip once captured. I did send Camille to the jail with Flying Hawk due to the fact I did have a D. U. S. warrant. I was not "angry" at Mo. Mitchell because it took her so long to get to Fargo - It was because Flying Hawk was high on meth and we had been shot at. Again I'll state, Ryan Youngren is a liar and a very poor representation of the North Dakota justice system. Flying Hawk testified at my trial "Troy gave me \$20 for a phone card for when I get to jail" - "Troy said I will give you \$200 of the \$500 I get for your capture to help you bail out" - "Troy and Camille let me empty my pockets at a garbage can because I had felonies on me." As for the title to Flying Hawk's vehicle - We went to a credit union where me and

Daniel offered them \$1000 to release his title so his vehicle wouldn't get re-passed. It was not to let him go. As for the "It's all about the \$" statement - Mr. Schienbier told me "I'll send you a check" - And it once took me 6 months to get paid for a different capture for a different company. So I told him - "It's \$500 cash on delivery" or Flying Hawk may get out of this car may run, and I may fall down and he may get away" - He hung upon me to be sure Sherri Mitchell had \$500 cash - I did then say "It's all about the \$". Again, Ryan Youngren is a liar - Let it be known to the Court that the charge of terrorizing came 9 months after the initial charges. I told Ryan Youngren "You're a punk ass bitch and I'm going to shove this case up your ass because you know no one was kidnapped" So, he re-interviews Flying Hawk - Now all of a sudden I "terrorized" him. I do admit, I was upset that we were

were shot at and said "I ought to pull you out of this car; whip your ass". There is Never the mention of "kill you" in the police report or at the trial - Yet Mr. Youngren decided to take the liberty of adding that phrase - hence again, he's a liar and misusing & abusing his legal power. As to Mr. Youngren's added lies that my Atty. Mr. Steve Mattinger cross examined the state witnesses with his "30 years of practice" effectively - Really? Why didn't Mattinger bring the fact up that Ms. LaCros's lied to the police in her statement she gave saying "Troy Lehman asked for \$ and meth to let Daniel go" which clearly contradicts her statement under oath at my trial when she was asked "Did Troy ask for money and meth to let Daniel go" by Mr. Youngren - To which she said "No! He did not." And it is obvious that since I gave Daniel Flying Hawk \$20 for a phone card once he got to jail

and that he could have \$500 of the \$500 I would receive for his capture to help repay bail - which was testified to in court by Daniel Flying Hawk - This also totally flies in the face of me working something with anyone for his release - yet Mottinger never made mention of it. I will admit, I do have a criminal history - But, I have a history of accepting the blame for wrongs I've done swiftly and without complaint. Nobody was kidnapped - Period! And it is all too obvious that it took 9 months to nail a terrorizing charge to the initial complaint. Do I believe the North Dakota Supreme Court will side with me? Not for (1) second - For (1), Mark Blumer has my appeal all messed up - He doesn't even have Ms Beyers name correct - Just shows you how "dedicated" court appt'd attys are - (2) To you people, I'm a piece of crap -

And you know what? Now, after being locked up for something I didn't do - I see why people have had no choice to view me as such.
