Page 1:

- **Top of form:**

1. Fill in the name of the County in North Dakota where the original juvenile court proceeding was decided.
2. Fill in your full, legal name on the Respondent line.
3. Fill in the case number(s) of the original juvenile court proceeding(s) on the Case No. line. If you do not know the case number or case numbers, contact the Juvenile Court Officer who managed your case.

- **Paragraph 1:**

1. Fill in your full, legal name.

- **Paragraph 2:**

1. Fill in the date you were charged with the delinquent or unruly acts.
2. Write the delinquent or unruly acts with which you were charged.

- **Paragraph 3:**

1. If the charges were dismissed, put a checkmark (✓) on the line next to “charges against the respondent were dismissed.” Fill in the date the charges were dismissed.
2. If you successfully completed the terms as ordered by the juvenile court, put a checkmark (✓) on the line next to “successfully completed the terms as ordered by the court.” Fill in the date you completed the terms. Successful completion includes probation, custody with the Department of Juvenile Services, and custody with the county.

3. If you paid restitution in full, put a checkmark (✓) on the line next to “respondent paid the required restitution in full.” Fill in the date you made full payment.
4. Add more lines, if needed.

- **Paragraph 4:**

1. Tell the juvenile court why you believe the juvenile court records should be destroyed early.
2. Write the reason or reasons why you are making the request.

Page 2:

- **Paragraph 5:**

1. If you want the court to consider destroying the juvenile court office records of any informal adjustments or diversions related to the juvenile court proceeding records, put a checkmark (✓) in the box next to “I am ...”
2. Otherwise, put a checkmark (✓) in the box next to “I am not ...”

- **Signature and Notary Public Lines:**

1. **DO NOT** complete the Signature and Notary Public until you are in front of a North Dakota Clerk of District Court or a notary public. The clerk or notary public will witness the signature and fill out and sign the Notary Public lines.
2. You will need to show a driver’s license or other photo identification to the clerk or notary public.
