FACTS OF THE CASE

The Appellant was sentenced to serve nine years, with six of those years imposed to be suspended, for a period of five years. The period of suspention, to be served on probation, with terms and conditions, as set forth by the Court.

The Appellant served his three years in the Department of Corrections, in North Dakota, and was released to the community to serve his suspended sentence, or probation.

After a period of time, the appellant violated his probation, and was re-sentenced to the North Dakota Department of Corrections, to a period of ten years. The Williams County District Court did not give the Appellant credit for the three years spent in the North Dakota Department of Corrections, or any of the days spent in the Williams County Jail, which amounted to about ten days.

Under the North Dakota Century Code, the Appellant must recieve credit for any time spent in custody for the charge that he is sentenced for.

The Appellant filed a "MOTION with the Williams County District Court, asking for the credits to the sentence that he is now serving. But, the Williams County District Court failed to give an answer to the "MOTION" filed.

ARGUEMENT

The Appellant is appelaing the denial of the Williams

County District Court's failure, to answer to a "MOTION" put

before the Court for credit spent in custody on the cases

that he is now serving. The Appellant was previously sentenced

to prison time, and probation on these charges.

At a later date, the probation of the appellant was revoked, and he was again sentnced to the North Dakota Department of Corrections to serve the remainder of his sentence.

According to the North Dakota Century Code, 12.1-32-02, (2), all persons sentenced to prison time for a charge, "shall" recieve credit for any time spent in custody, whether it be in a hospital, jail, treatment facility, or other institution deemed to be in an enviorment where the person is not free.

The Appellant did serve three years in the North Dakota Department of Corrections on the first sentence imposed. He, was later re-sentenced to more prison time, but the Court failed to give the appellant any credit for time spent on the charges, or case number listed on the cover sheet. The Appellant also served about ten (10) days in the Williams County Detention center waiting for the probation revocation hearing to be held.

RELIEF SOUGHT

The Appellant seeks the proper credits that are due him by the North Dakota Statue, that is afforded all persons that are sentenced for criminality in this state.
