Re: Juvenile Policy Board

Dear Justice VandeWalle,

I am writing to inform you of a recent development that affects my position on the Juvenile Policy Board. Due to various reasons, the Juvenile Court Association has recently voted to disband and discontinue the Association. Therefore, as of March 31, 2019, there is no longer a Juvenile Court Association within the State of North Dakota.

I understand my position on the Juvenile Policy Board is directly tied to Administrative Rule 35, Section 3 (Membership), which allows a Juvenile Court Association member on the board. Therefore, I feel it is only appropriate to resign my position on the Juvenile Policy Board effective immediately.

However, I do want to encourage the Supreme Court and Juvenile Policy Board to consider another method to allow representation from Juvenile Court Officers on the board, similar to the Personnel Policy Board. Through my experience on the board, I have realized having a Juvenile Court Officer as a voice on the board can offer a direct and unique perspective when it comes to developing policies within the Juvenile Court. It also helps Juvenile Court Officers develop valuable experience that can be used in their current positions or if they would pursue advancement within the Supreme Court.
