PETITION FOR SUPERVISORY WRIT

[¶1] The North Dakota Attorney General, Drew H. Wrigley ("Wrigley"), petitions this Court for relief in the form of a supervisory writ to be issued under this Court's original jurisdiction, directing the respondent, The Honorable Judge Bruce Romanick, to vacate his

August 25, 2022, Order Granting Plaintiff/Respondent Red River Women's Clinic's ("RRWC") Motion for Preliminary Injunction in Burleigh County District Court No. 08-2022-cv-1608, which enjoined N.D.C.C. § 12.1-31-12.

[¶2] Exercise of this Court's original jurisdiction under N.D. Const. art. VI, § 2 and N.D.C.C. § 27-02-04 is proper to rectify errors and prevent an injustice because Wrigley may not appeal Judge Romanick's Order enjoining Section 12.1-31-12, and the injunction presents significant issues of public concern.

[¶3] Judge Romanick abused his discretion because he enjoined Section 12.1-31-12 without considering the substantial probability of succeeding on the merits factor ("merits factor"), which courts must consider when evaluating motions for preliminary injunctions. Judge Romanick's Order enjoining Section 12.1-31-12 is legally erroneous because it is not supported by this Court's precedent or the State Constitution.

[¶4] Judge Romanick's Order enjoining Section 12.1-31-12 should be vacated in its entirety.
