## Instructions for Summons (Petition) – Civil Action, or Civil Case

A Summons directs the Respondent to answer the Petition within a certain amount of time. The Summons notifies the Respondent that a default judgment will be taken against them if the Respondent doesn't answer.

Fill in the name of the North Dakota County where the Petitioner intends to file the civil action, or case.
Fill in the name of the Judicial District where the Petitioner intends to file the case. (The County is within the Judicial District.) County and Judicial District information and maps are available at <a href="mailto:ndcourts.gov/court-locations">ndcourts.gov/court-locations</a> .
Leave the case number blank unless a rule or law tells you differently.
Fill in the full, legal name of the Petitioner on the Petitioner line. There can be more than one Petitioner.
Fill in the Respondent's full, legal name on the Respondent line. There can be more than one Respondent
Sign and date the Summons.
A copy of the Petition must be served with the Summons.
