Instructions for Form 4: Declaration of Default, Identification and Active Military Service

(Form MP4: Declaration of Default, Identification and Active Military Service is part of the Motion for Default Parenting Responsibility Judgment. [Review the instructions for the packet of forms.](#))

ND Legal Self Help Center Staff and Court employees **can't** help you fill out forms. If you're unsure how to proceed, consult a lawyer.

ND Legal Self Help Center forms **aren't** official court forms. Judges and courts aren't required to accept them. There's no guarantee Center forms will be accepted. Use at your own risk.

Don't include these instruction sheets when you serve or file the completed form.

A Declaration of Default, Identification and Active Military Service is one of a set of required documents that make up a written Motion for Default Parenting Responsibility Judgment.

The MP4: Declaration of Default, Identification and Active Military Service form is your, the Plaintiff's, written statement of the Defendant's default in answering the Summons and Complaint, the Defendant's address and occupation, and the Defendant's active military status.

You, the Plaintiff, arrange to serve the Declaration of Default, Identification and Active Military Service with all of the other required documents listed on Page 3.

You, The Plaintiff, Complete and Sign This Form.

- Top of Form (Caption):** Fill in the caption exactly as you filled in the caption on the *Summons*.
- Fill in your full legal name.** This should match your name in the Caption.
- Paragraph 1:** Read carefully. If this information isn't correct, you **can't** use this form.
- Paragraph 2:** Check (✓) the first box if you know Defendant's address. Fill in all of the information for the Defendant. If you don't know the Defendant's occupation or employer's name or address, write "Unknown" in the appropriate space.

Check (✓) the second box if you **don't** know Defendant's address, describe the steps you took to try to find the Defendant for service.

- Paragraph 3:** Fill in the same date as Paragraph 3 of your Form 3: Brief.
- Paragraph 4:** Check (✓) the same box as Paragraph 4 of your Form 3: Brief.
- Paragraph 5:** Check (✓) the same box as Paragraph 6 of your Form 3: Brief.

If you check (✓) the second box, describe the contact.

- Paragraph 6:** Check (✓) the same box as Paragraph 5 of your Form 3: Brief.

If you check (✓) the first or fifth box, fill in the information.

If you check (✓) the second, third, or fourth box, the **entire** statement must be true, or you can't use this form.

- Date and Signature:** You, the Plaintiff, must sign and date the Declaration of Default, Identification and Active Military Status.

What do I do next?

- Set aside the completed Declaration of Default, Identification and Active Military Status form. (You make copies later.)
- Complete the next form in the set. (The Declaration of Proof for Default Parenting Responsibility Judgment is the next form.)
- Once you've completed all of the forms listed on Page 3, you serve the Declaration of Default, Identification and Active Military Status with those forms.
- The originals are filed with the court in **Step 7**. Make sure to also file the Declaration of Service by Mail.

- MP9: Exhibit A: Parenting Plan; and
- MP10: Declaration of Service by Mail.

For Default Parenting Responsibility Judgment the following form is optional and isn't served:
