## Instructions for Declaration of Petitioner: Criminal History Records Checks and/or Objections

Don't include these instruction sheets when you serve or file the completed form.

A Declaration is a written statement of fact given by an individual with first-hand knowledge of the facts.

As of March 1, 2018, in general, notarization isn't required when a Declaration will be filed in a civil case with a North Dakota state district court.

The Declaration of Petitioner: Criminal History Records Checks and/or

Objections is used when you're notified by the Court in your name change case that you:

- 1. Must obtain a criminal history records check; And/Or
- 2. **Must** wait 30 calendar days from the date of publication of the Notice of Petition for Name Change. After 30 days has passed, you **must** file an Affidavit or Declaration stating whether you received any objections to your notice of name change.
