REGISTRATION OF OUT-OF-STATE OR TRIBAL COURT PROTECTION ORDER  
(Reg Foreign PO CIF)**

Do not include this instruction sheet when you file the completed form.**

**Local courts may have a preferred form. Contact the Clerk of Court in the County where you  
will register the protection order to find out if a local form is preferred.**

- **Top of Form:**

1. Fill in the top of the form exactly as you filled in the top of the Affidavit for Registration of Out-of-State or Tribal Court Protection Order form.
2. When you take this form to the clerk of court, you will be given a case number. At that time, write the case number on the Case No. line.

- **Petitioner, Respondent and Minor Child Information:**

1. This gives the court the confidential information that cannot be included in the affidavit. This form remains confidential and is not a public record.

2. **Full Information Column:**

- a. Fill in the full information for Petitioner.
  - This is required for every protected party:
    - Full name
    - Birthdate – Month/Day/Year
- b. Fill in the full information for Respondent.
  - Full name
  - At least one of the following is required:
    - Birthdate – Month/Day/Year
    - Social Security Number
  - If you listed the year of birth or last 4 digits of the social security number on the Affidavit for Registration of Out-Of-State or Tribal Protection Order, you must list the full information on this form.
- c. Fill in the full information for the minor child(ren)
  - This is required for every protected minor child:
    - Full name
    - Birthdate – Month/Day/Year

**3. Redacted Information Column:**

- a. Fill in the information as it appears in the Affidavit that will be seen by the public.
4. Add additional children on a separate sheet of paper. Do not write on the back of the form.

• **Date and Signature:**

1. Fill in the day of the month, the month and year of the date you sign this document.
2. Sign the signature line.
