NORTH DAKOTA LEGISLATIVE HISTORY RESEARCH - QUICK GUIDE

Legislative history research refers to using documents and/or audio recordings produced during the bill or resolution process to attempt to determine the North Dakota State Legislature's intent, or to clarify vague or ambiguous language.

Commonly, legislative history is bill or resolution versions, and committee hearing minutes and testimony.

Basic Steps:

- 1. Find the North Dakota Session Laws for the statute.
- Use Session Laws to identify the bill(s) or resolution(s) by the year of the legislative session and the House or Senate bill number.
- 3. Using the year of the legislative session and the bill or resolution number, locate the legislative history, which may be available online, in print, on microfiche, or audio recordings.

FIRST, FIND THE NORTH DAKOTA SESSION LAWS FOR THE STATUTE:

The first step in legislative history research for the North Dakota Constitution and North Dakota statutes is to find the session laws and/or dates of enactment and amendment for the specific section.

The North Dakota Century Code at <u>legis.nd.gov</u> doesn't include session law information. You'll need to use an alternate source.

- **S.L.** = Session Laws of North Dakota. Session Laws are published after each regular and special legislative session and contain the laws enacted or amended that session.
- Year = Year of the North Dakota legislative session when the law was enacted or amended.
- **ch.** ### = Chapter Category. Every bill introduced in a legislative session is placed in a numbered chapter category that generally fits the subject matter.
- § # = Section. Every chapter category is divided into sections. Each section contains the text of the law or amendments to an existing law. Section numbering begins at 1.

SECOND, LOCATE THE BILL OR RESOLUTION YEAR AND NUMBER:

Go to the session law(s) to find the bill or resolution number in the heading of the session law chapter.
