Instructions for using the Attorney Subscription Manager

The Attorney Subscription Manager allows attorneys to subscribe to a notification email service that will email attorneys and their staff within one hour of an event being added on any district court case where you are the attorney of record on the case. (You must be designated as the attorney of record in the Odyssey system in order for this notification service to work. If you are not designated as the attorney of record in Odyssey and should be, contact the clerk of court in that county to get the Odyssey system updated.)

Once setup, you could receive one email per hour that will include all of the newly added case events of your choosing on all of your cases. If no new events were added on any cases, you would not receive an email that hour.

To subscribe to this service, log into this website: <u>http://subscribe.ndcourts.gov/</u>. You should be presented with a screen similar to the one below. Use your Court provided User Name and Password that you normally use today to view cases and case documents on the Odyssey Secure Public Access system. Click on "Login" after entering your user name and password

You can either select them individually or use the "Select All", to choose all of them. Be sure to look through each tab – Order, Motion, Service, etc. and choose all of the Odyssey case events you want to be notified on under each tab.

Enter the email addresses you want to receive the emails. Separate multiple email addresses with either commas (,) or semi-colons (;). Do not use other characters to separate the emails.
