## REIMBURSEMENT FOR MEALS AND LODGING

Reimbursement claims for meals and lodging will be allowed:

- when the judge or court employee travels to a location other than their city of residence, their chambered city, or principal place of employment and is away for at least 4 hours;
- when more than 50% of the assigned work is located outside the chambered city, the Supreme Court may designate a place of primary workload for purposes of this policy; in this circumstance, a judge or court employee is entitled to meals and lodging while attending to business in the chambered city if the time spent away from the place of primary workload is at least 4 hours;
- when attending a conference, educational program, or a meeting unless meals and lodging are provided and paid for by another source (reimbursement for meals in city of employment will be allowed only when attendance is expected during the meal).

The travel expense allowance for each quarter of any twenty-four hour period is as follows:

## Meals

1st Quarter 6:00 am - 12:00 noon (No reimbursement if travel began after 7:00 am)	\$9.00	20% of GSA* daily rate
2 <sup>nd</sup> Quarter 12:00 noon - 6:00 pm	\$14.00	30% of GSA* daily rate
3 <sup>rd</sup> Quarter 6:00 pm - 12:00 midnight	\$22.00	50% of GSA* daily rate
4 <sup>th</sup> Quarter 12:00 midnight - 6:00 am

## Lodging

**In-State:** \$99.00 plus any additional applicable state or local tax.

A lodging receipt is required when claiming reimbursement for lodging. The single person room rate must be provided. No receipts are required for meals.

Out of State: Actual expense.
