

# An Semirit Kewe Pwuung ren Ew Juvenile Detention Hearing

Ran annim. Auche an ei arongorong ika hearing ikenai an epwe fat ika kopwene tongeni no ngeni neniom ika mi fen wor ekkoch me nukun ach sipwe sopweino ne anomwuk non detention ika fen ekkoch me nukun.

Ika ewe Court a finata me nenengeni nge kose fori ekkei fofor re atipisuk won ika fen ekieki pun epwe appetuk ika appeti ekkoch iwe ese mumuta omw kopwe tou ikenai.

Me nukun chok, ewe soukapwung ika judicial referee epwe meni order omw kopwe nomwetiw non detention ika repwe amwokutuk ngeni ekkoch neni.

Ewe Court epwe meni pwan mwut ngonuk omw kopwe niwiniti neniom ren ekkoch wewe. Ekkena wewe epwe pachenong tichikin ren inet ika pwata ka tongeni tou seni neniomw, pwan tichikin ren io mei tongeni nomw remw, eaea electronic monitoring device ar repwe sinei omw mwokutukut, ika apachanong iinomw/semomw ika chon tumwunuk ar repwe tumwunuk ren mwokutkutumw.

Ir mei tongeni aukatiw ei hearing ika ewe Court a finata pun ese wor emon epwe tumwunuk. Ika court a finata ikenai pun ese wor emon epwe tongeni tumwunuk, ewe soukapwung ika judicial referee mei tongeni aukano ei hearing, iwe ewe semirit mi need aninis fanitan an we keis epwe fael. Epwe wor ew hearing fanitan nenan ewe semirit repwe awora fansoun inet chok a tongeni fis nge esapw mang seni 96 awa. Tiwe-me-onu awa mi wewe ngeni 4 ran, esapw pachenong weekends me holidays.

Me mwan ach sipwe sopwosopwono ei hearing, en mi need omw kopwe sinei pun ekkewe pwuung epwe apply. Mei wor omw pwuung an epwe wor noum attorney, ika lawyer, epwe wisen tupwunuk. Fan annukun North Dakota, emon lawyer epwe kawor fanitomw ika ese wor lawyer mi fen representinu k ika anisuk.

Ika repwe ngonuk emon lawyer, ewe soukapwung ika judicial referee epwe orderini iinomw me semomw ika emon chon tumwunuk epwe wisen meeni ngeni state niwinin noumw we lawyer.

En mei tongeni weifini, ika fangeta, ewe chok pwuung fanitan ewe lawyer ika pun ierum mi engon-me-ruanu nge ewe court mi finata omw kopwe pusin finata nge pwan weweiti met epwe fis ika esapw wor noum lawyer.

Iinomw/semomw ika io chon tumwunuk ir mei tufich ne angei ruemon lawyer seni court nge epwe chok ngeni ru kinikinin kapwung. Ekkei ru kinikin ra eita ngeni detention hearing, iei nupwen ewe court a finata ika ewe semirit a tongeni no ngeni nenan ika esapw iwe ewe

deposition hearing ewe mi chok wewe ngeni ew sentencing hearing an emon adult ika serafo epwe charge ren ew crime.

Ika kopwe angei emon lawyer seni court, kopwe amasowa ei application iwe ewe judicial referee ika soukapwung epwe finata ika en mi qualify ika tufich ren emon lawyer anonganong won noumw income. Emon iin/saam ika ekkoch epwe meni wor nour lawyer non meinisin mwokutukut, nge repwe pusin meeni.

Mei wor ekkoch annuk ren ukukun taman an emon semirit epwe tongeni nomw non detention nge esapw fan an court order. Iwe seni ekkei annuk, ika mwo iinomw/semomw ika chon tumwunuk repwe sosot ne kut nour lawyer iei ika ekiekin kut nour lawyer, ewe court epwe awora ew hearing iei an epwe nenengeni ika kopwe tongeni no ngeni neniom. Ika rese sani met ewe soukapwung ika judicial referee ra finata iei ir mei tongeni pwan tungor ew hearing ar repwe review-ni ewe finata.

Mei wor omw pwuung an epwe wor ew hearing ren ena osukosuk ika epwe tufich tameno omw detention.

Mei wor omw pwuung omw kopwe fanefaneno me kosapw poraus won pusin inisum faniten met ir mei atipisuk won.

En mi “presumed innocent”. Wewen pun esapw omw angang omw kopwe pwarata pun kose fori met ir mei tipi ngonuk won. An state angang ar repwe pwarata ngeni court pun en mi fori met re atipisuk won.

Ew an ewe judicial referee ika soukapwung angang ikenai repwe finata ika mei wor popun ar repwe nuku pun en mi fori met re atipisuk won. “Probable cause” esapw wewen en mi guilty. mi chok wewe ngeni anonganong won ekkewe poraus mi wor ren ewe soukapwung ika judicial referee, mi pwan tufich ar repwe ekieki an emon epwe fori ei fofor nge en chon atutur ren, iwe mei pwan tufich ar repwe nuku pun ewe aramas e fori ekkei fofor epwe en.

Pun ewe judicial referee ika soukapwung ra chok nenengeni ewe probable cause iei, esapw wor fansoun ar repwe pwarata ekkewe pisekin pwarata, ika awora chon pwarata. Murin me non court, ir me ru, state me en epwe wor ami fansoun ami oupwe uwanong chon pwarata me pwan awora pisekin pwarata me aporausa met mi fis, nge ren ei esapw fis ikenai.

Ika ewe court epwe kuna probable cause ikenai, ewe soukapwung ika judicial referee mei tongeni finata an epwe fori ew me nein ekkei mi tetenitiw:

- Repwe release-inuk ngeni iinomw/semomw, chon tumwunuk, ewe chon nemenem, ika ekkoch chon tumwunuk me tongeni anomwuk me pwan tongeni uweiuketiw ngeni court ren omw kapwung.
- Repwe release-inuk ngeni iinomw/semomw, chon tumwunuk, ika ekkoch chon tumwunuk fanitan ekkoch pekin home confinement. Wewen home confinement ren emon mi watte an epwe wisan tumwunuk iteitan, iwe en mei tongeni tou seni iimw fanitan ekkoch popun ren appointment, sukun, ika omw angang.
  - Home confinement mei pachenong ririn pechemw ar repwe tongeni sinei

- mwokutukutumw.
- Orders ren home confinement epwe chok tori omw trial ren ekkewe charges me nesopwonon kapwung.
  - Ren sopwosopwonon omw kopwe nomw non nenian detention

Ew petition ika mwokutukut epwe fael non ukukun nimu ran seni ewe state lawyer. Ewe petition epwe echo taropwe mi mak seni ewe state lawyer epwe awewei met re atipisuk won mi pwan pachenong porusan met mei fis.

Ika ewe petition ese fael non ukukun nimu ran, iwe ka tongeni release ika tou seni detention.

Ika rese faelini non ukukun nimu ran, iwe ka tongeni tou seni detention.

Ika ewe judicial referee ika soukapwung epwe order an epwe kamareno ewe detention, fan ekkoch ewe order epwe wes manamanan ika expire non 14 ran.

En ika iinomw/semomw mi tongeni tungor pwan ew detention hearing ese pwan nifinifin fansoun ika mei wor omw akkot fanitan omw kopwe tou. Ren omw kopwe sopweino omw nomw non detention epwe wor ew detention hearing epwe fis iwe state epwe pwarata pun mei wor met mi tongeni efeiengaw ke uwata fanitan public safety iwe ren ei iwe ese wor met me nukun. Ika epwe namot, en ika iinomw/semomw mi tongeni tungorei ewe judicial referee ika soukapwung ar repwe fori pwan ew detention hearing inet chok oua mochen, ika pun mi fen wor ami akkot ika plan fanitan omw kopwe tou. Ren omw kopwe tungor an epwe wor ew review hearing, ka tongeni contact ewe clerk of court ika ewe ofesin juvenile court.
