Personal Service

- If you, the Plaintiff, decide to arrange to serve a copy of the Summons and Complaint by personal service, the person who serves the documents must be at least 18 years old and not a party in the action or interested in the action.
 - o You, the Plaintiff, can't serve the documents yourself!
- The person must serve the documents as required by Rule 4(d) of the North Dakota Rules of Civil Procedure.
- The person who served the documents must fill out a Declaration of Service by Personal Delivery and sign and date the Declaration.
- You, the Plaintiff, file the signed and dated Declaration of Service by Personal Service.

Complete the Declaration of Service by Personal Delivery

You, the Plaintiff, Fill in the Top of the Form

The information to fill out the top part of the form ("the caption") is the same as on the Summons form.

- Fill in the full, legal name of the spouse who is listed as the Defendant.
- Leave Case No blank. When all of the completed documents are accepted for filing, the Clerk of Court assigns a case number.
