[1.] Appellant asks this Court to analyze special factors to correct clear error and prevent manifest injustice. Special factors:

[2.] The District Court failed to grant leave for the amended petition in case # 08-2019-CV-00166 (Index # 148).

[3.] The District Court also failed to grant leave for the amended petition in case # 08-2019-CV-00258 (Index # 142).

[4.] In Judge Grinsteiner's order on petition dated 4-8-21, he referred to only one petition that was filed "on July 27, 2020." That amended petition is "Index # 148" (see ¶ 2). He didn't mention the other petition, and he never granted leave for either petition; therefore, neither were operative.

[5.] The fact that no "amended petition" was operative, caused undue prejudice to Appellant in the form of unlitigated claims and judicial error.

[6.] These cases may need to be remanded and have errors corrected by the District Court before proceeding any further.
