[¶1] COMES NOW the Defendant/Appellant, Dalton Gene Peltier, by and through his attorney, James R. Loraas, and submits this Request for Extension of Filing Deadline to the North Dakota Supreme Court pursuant to Rule 26(b) of the North Dakota Rules of Appellate Procedure.
