**REQUEST FOR TESTIMONY BY RELIABLE ELECTRONIC MEANS**

[¶1] An evidentiary hearing is scheduled for August 23, 2022, beginning at 9:00 a.m. On behalf of the Petitioners, the undersigned respectfully requests the Court permit Petitioners' witnesses: Zeph Toe, Valerie Pachulski, Chloe Lloyd, and Tim Mooney, to testify via Zoom or other reliable electronic means. Each of the aforementioned witnesses resides outside of the Bismarck area and has been unable to coordinate travel to ensure personal appearance at the hearing on short notice. 

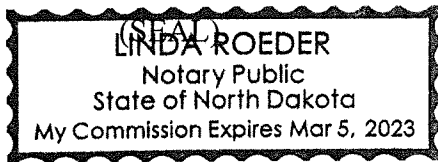


